70 stranded at Munnar resort, army deployed

Around 70 people are stranded in a resort in Munnar after the roads to the resort were blocked due to a landslide. Of the 70 tourists, 20 are believed to be foreigners. The army, which has been deployed in the flood-hit areas in Kerala, will be evacuating the tourists using helicopters.

The Centre today assured the Kerala government of all possible help in rescue and relief operations in the wake of rains and floods, which so far have claimed 26 lives in the state. The assurance was given by Home Minister Rajnath Singh to Kerala Chief Minister Pinarayi Vijayan during a telephonic conversation.
