Examination for confirmation of enrollment of **GST Practitioners to be conducted by NACIN** New Delhi: The National Notification no. 03/2019-Central

Academy of Customs, Indirect Taxes and Narcotics (NACIN) has been authorized vide Notification No. 24/2018-Central Tax dated 28.5.2018, to conduct an examination for confirmation of enrollment of Goods and Services Tax Practitioners (GSTPs) in terms of the sub-rule (3) of Rule 83 of the Central Goods and Services

Tax Rules, 2017. The GSTPs enrolled on the GST Network under sub-rule (2) of Rule 83 and covered by clause (b) of sub-rule (1) of Rule 83, i.e. those Meeting the eligibility criteria of having enrolled as Sales Tax Practitioners or Tax Return Preparer under the existing law for a period not less than five years, are required to pass the 31.12.2019 in terms of opportunity/chance.

Tax dated 29.01.2019. Two such examinations for such GSTPs have already been conducted on 31.10.2018 and 17.12.2018.

In terms of Rule 83A(3) of CGST Rules, 2017, the examination shall be conducted twice in a year by NACIN. Build up inflation rate in the financial year so far was 0.75% compared to a build up rate of 0.86% in the corresponding period of the previous year. The index for this major group rose by 3.3 percent to 139.2 (provisional) from 134.7 (provisional) for the previous month. The index for 'Food Articles' group rose by 3.4 percent to 150.1 (provisional) from 145.1 (provisional) for the previous month due to higher price of tea (15%), fruits & vegetables peas/chawali (6%), maize (5%), poultry chicken (4%), arhar, bajra and pork (3% each), gram and condiments & spices (2% each) and masur, urad, mutton and raima (1% each).
